

## BIOGRAPHY

SANDRA M. LAMBERT is the CEO of Lambert & Associates, LLC, located in Los Angeles (<http://www.lambert-associates.com>), where she specializes in cybersecurity & business continuity consulting, with an international clientele. She is an internationally published author & lecturer on information systems security. Prior to full-time consulting, she completed a 5-year assignment at Citibank as the Director of Information Security with responsibility for developing the corporate information security program. With staff located in the Northeastern States, she established the budget & management infrastructure, defined the enterprise-wide security architecture, devised information security policies, updated/standardized security & cryptographic product usage, and managed 24x7 cryptographic operations & customer support. Through her development of education forums & presentations to the Bank's Fortune 100 customers, Ms. Lambert transformed information security from a perceived nuisance into a positive marketing feature that enabled multiple Citibank business opportunities, resulting in increased revenue. She was also associated with Security Pacific Corporation (SPC), parent company of Security Pacific National Bank, for 15 years where she served as Vice President & Manager of the Information Systems Security Division. Ms. Lambert was responsible for SPC's global information security program, including policy development, disaster recovery planning for their data centers in three states, security administration of mainframe & midrange processors, security awareness training, & conversion of business acquisitions to SPC information security standards. She managed the development & implementation of security strategies, architectures, technologies & standards for all computers and communication networks. Ms. Lambert held a four-year term on the National Computer System Security & Privacy Advisory Board established by the Computer Security Act of 1987, and a six-year term on the NIST Information Technology Lab Assessment Board. In addition to serving 10 years as Vice Chair of the American National Standards Institute X9F Committee on Information Security Standards for the Financial Services Industry, she worked on X9F1 (Cryptographic Tools), X9F4 (Cybersecurity and Cryptographic Solutions) of which she is currently Vice Chair, & X9F5 (Certificate Policies & Practices). She was the Editor of ANSI X9.95 Trusted Time Stamp Management & Security. Ms. Lambert served on the National Academy of Sciences Systems Security Study Committee where she co-authored Computers at Risk: Safe Computing In The Information Age, National Academy Press, 1991. She is the former Chairperson of the Board, Founder & founding President of the Information Systems Security Association, is a Distinguished Fellow, member of the Honor Roll, and was elected their first inductee into the Hall of Fame. She is the current Chairperson of the Board of the ISSA Education Foundation. Ms. Lambert was awarded the 2009 (ISC)<sup>2</sup> Tipton Lifetime Achievement Award for her contribution to the information security profession, and the 2004 SecurE-Biz Pioneers Award in recognition of outstanding performance in securing the National Critical Infrastructure. She served on the (ISC)<sup>2</sup> North America Advisory Board. Ms. Lambert is past Chair of the Bank Administration Institute Data Security Committee, and, as a member of the Los Angeles County Computer Crime Task Force, she participated in the development of and gave expert testimony supporting the update of California computer crime legislation. Ms. Lambert is a Certified Information Systems Security Management Professional (CISSP-ISSMP), Certified in Disaster Recovery Planning, Certified in the Governance of Enterprise IT (CGEIT), CCP and CISA. In addition, she holds an MBA, MS (Mathematics), & was an accredited CISSP trainer as well as college level mathematics instructor. Ms. Lambert is listed in Who's Who in California, Who's Who in the West, Who's Who of Emerging Leaders in America, and National Register's Who's Who in Executives & Professionals.
